OBJECTIVES

- Improve reception, integration and protection of refugees and asylum seekers affected by the Syrian and Iraqi crises in Turkey, through protection mechanisms and sustainable integration - with a particular focus on Iraqis - as well as strengthened capacity of local authorities to receive refugees and asylum seekers in Turkey.

- Provide counselling services, including a referral system.

HOW DO WE WORK?

Provide counselling services and integration activities in sustainable living centres (SLCs) and field offices (FOs):

- Establish 4 SLCs and 2 FOs.
- Recruit and train 56 staff.
- Provide counselling services, such as legal, primary health care and specialised services for the disabled.
- Organise integration activities, such as language courses, peacebuilding activities, life-skill building courses, awareness-raising activities, focus group discussions and peer information activities.

Provide counselling and referrals through the counselling line (CL):

- Increase the capacity of the CL by adding 5 counsellors.
- Provide counselling by phone and make necessary referrals to local authorities.

Conduct outreach activities through mobile counselling teams (MCTs) to reach vulnerable refugees and asylum seekers:

- Conduct 4,600 house visits.
- Reach 14,000 people through house visits.
- Conduct 25,000 counselling sessions and referrals.

Strengthen the dialogue with local authorities:

- MCTs arrange information/experience/resource sharing meetings with local authorities.
- SLCs and FOs regularly visit, and hold meetings with, local authorities.

Establish a functioning internal and external referral system:

- Provide social and legal counselling and basic health counselling.
- Make internal referrals between ASAM offices to psychologists or to health educators.
- Make external referrals to the public service providers.

Provide cash and in-kind assistance for the most vulnerable beneficiaries:

- Evaluate each case in terms of its vulnerability and also the need for financial support.
- Provide both cash and in-kind assistance for 2,000 people.

Organise trainings regarding the law on refugees and asylum seekers and referral pathways in Turkey for Directorate General for Migration Management (DGMM) staff.

Organise trainings and workshops regarding the law on refugees and asylum seekers, referral pathways, and project development for municipalities.
