Living and Working Together Integrating Syrians under Temporary Protection to Turkish Economy

OBJECTIVES

- Enhance the economic and social empowerment of Syrians and local community members, while strengthening their resilience and helping them become an asset for the local economy and economic growth potential.

EXPECTED RESULTS

- Inform at least 3,000 companies about the legal requirements and procedures for employing foreigners under temporary protection.
- Provide skill mapping for at least 30,000 SuTPs/Turks, to enable them to receive vocational guidance.
- Provide vocational guidance for at least 30,000 SuTPs/Turks.
- Allow at least 20,000 SuTPs/Turks to participate in preparation programmes (2 days) at voluntary companies.
- Certify at least 15,000 SuTPs/Turks so they can validate their qualifications to enter in the labour market.
- Companies to employ at least 3,000 certified SuTPs/Turks.
- Provide Turkish language courses for at least 2,000 certified SuTPs.

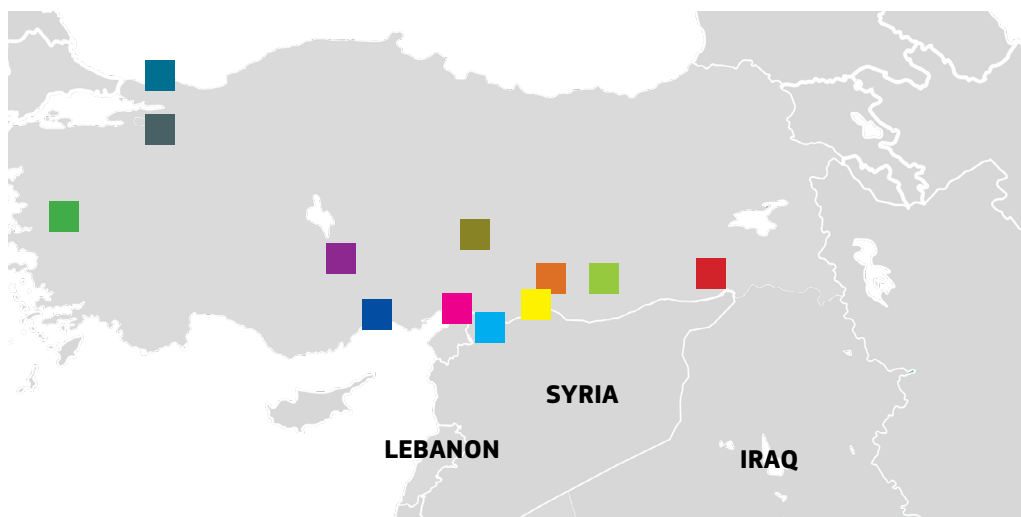

HOW DO WE WORK?

- Organise five awareness-raising meetings in each province.
- Identify selection criteria to identify the SuTPs and host community members who possess skills/qualifications to be eligible to take the vocational certification examination.
- Conclude profile making for 30,000 SuTPs and host community members.
- Prepare a guidebook for available vocational training courses in 12 provinces.
- Identify at least three authorised certification bodies to establish cooperation agreements.
- Sign service contracts with 180 programme experts.
- Identify 1,000 voluntary companies, which will host SuTPs and host community members for two days, during the orientation programmes.
- Provide translation services from Turkish to Arabic/Arabic to Turkish for SuTPs, during orientation programme days.
- Ensure that at least 20,000 SuTPs and host community members will participate in the two-day orientation programme.
- Translate all relevant vocational standards and test materials in Arabic.
- Test at least 20,000 SuTPs and host community members and 15,000 of them to be certified.
- Match companies and SuTPs and host community members and organise 150 speed dating events.
- Provide financial incentives to companies that will employ 3,000 certified SuTPs and host community members under the scope of the Project.
- Enrol 2,000 SuTPs in Turkish language courses.
- Establish a web based online information platform for recording the data of SuTPs and host community members, in addition to a monitoring system for the financial data of the project.
